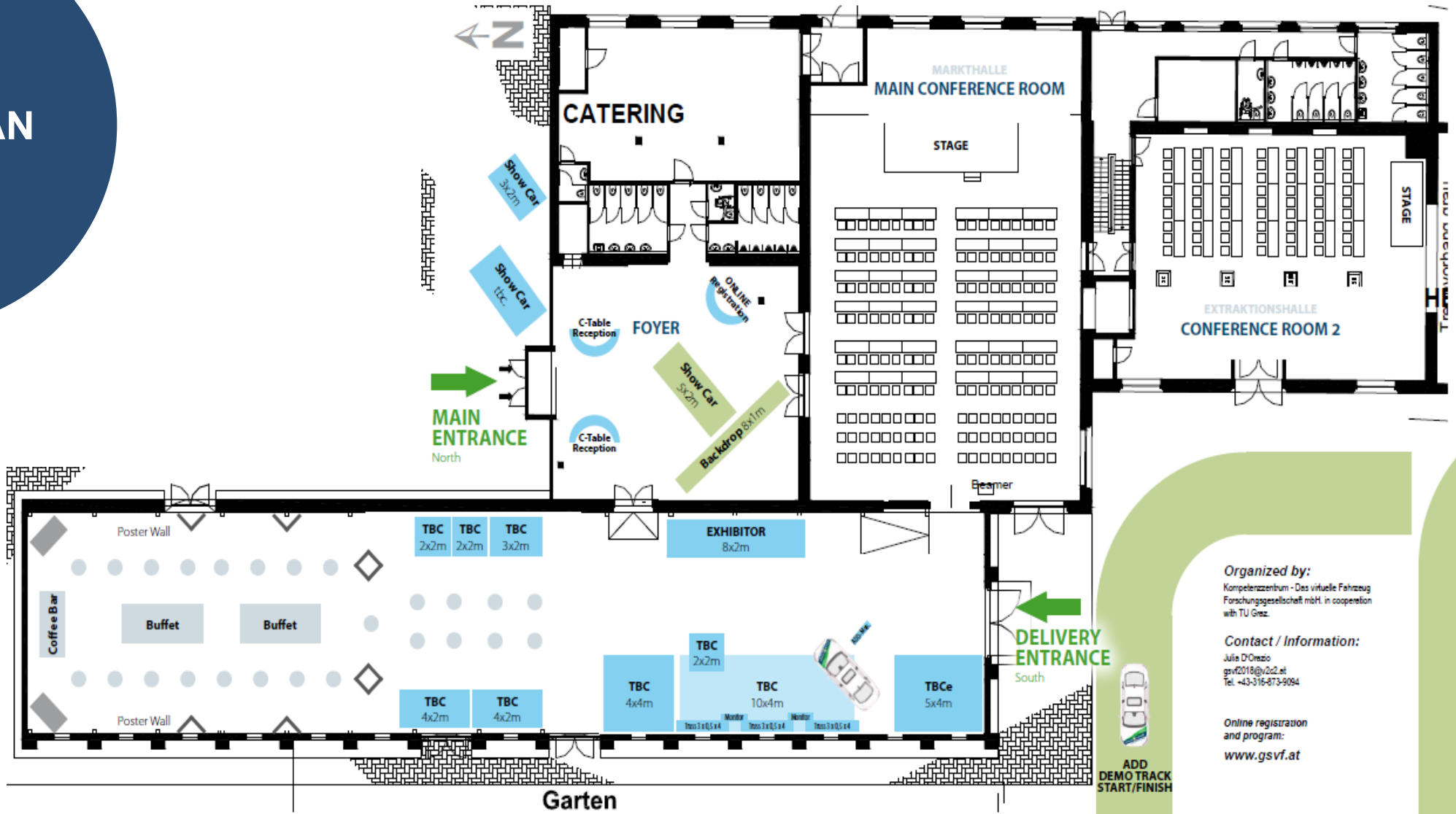

3. The exhibitor shall further comply with all terms and conditions (e.g. booth specifications, times, delivery etc.) described in the Exhibitor Information.
4. Neither ViF nor any of its contractors, employees or other representatives shall be held liable for, and are hereby released from any damage, loss, harm, or injury to the person or property of the exhibitor or any of its visitors, officers, employees or other representatives, resulting from theft, fire, water, unavailability of the exhibition facility, accident or any other cause.
5. To the fullest extent permitted by law, the exhibitor shall indemnify, defend, and protect ViF and hold ViF harmless from any and all claims, demands, suits, liability damages, losses, costs, attorney fees and expenses of any kind that might result or arise from any action or failure to act on the part of the exhibitor, its officers, employees or other representatives.
